2. **QUALIFYING REQUIREMENT**: Qualifying requirement for the above package(s) shall be as under:

Qualification of the Bidder: - Qualification of Bidder will be based on meeting the minimum pass/fail criteria specified below at serial no 2.1 and serial no 2.2, regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules.

Sub-contractor's technical experience and financial resources shall not be taken into account in determining the Bidder's compliance with the qualifying criteria.



The Employer may assess the capacity and capability of the bidder, to ascertain that the bidder can successfully execute the scope of work covered under the package within stipulated completion period. This assessment shall inter-alia include (i) Document verification (ii) Bidder's works visit (iii) Details of works executed, works in hand, anticipated in future & the balance capacity available for the present scope of work (iv) Details of plant and machinery, manpower and financial resources (v) Details of quality systems in place; (vi) past experience and performance; (vii) customer feedback; (viii) Banker's feedback etc.

Bihar Grid Company Ltd (BGCL) reserves the rights to waive off minor deviation, if any, that do not materially affect the capability of the bidder to perform the contract.

2.1: - TECHNICAL EXPERIENCE: -

The Bidder shall have Successfully# completed physical construction of any Type of Building work (Except prefab building works) as a contractor within the last seven years as on originally scheduled date of bid opening, as per following.

- I. One single work/project (excl. taxes) of a value of not less than Rs.396.91 Lakhs OR
- II. Two works/projects (excl. taxes), each of a value of not less than Rs.248.07 Lakhs OR
- III. Three works/projects (excl. taxes), each of a value of not less than Rs.198.45 Lakhs

Successfully completed means issue of provisional or final taking over certificate (TOC) by the Employer to the contractor for the referred contract.

Note: In case of works executed under a contract that had been awarded on a Joint Venture, the experience of individual Joint Venture partner shall be considered limited to the scope of that partner under the said contract.

In case bidder is a holding company, the technical experience referred to in Clause. 2.1 above shall be of that holding company only (i.e excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the technical experience referred to in Clause 2.1 above shall be of that subsidiary company only (i.e excluding its holding company).

Documents to be submitted by the Bidder as evidence of meeting the above QR:

- (i) Copy of Letter of Award/ Purchase order (along with detailed BOQ)
- (ii) Completion Certificate(s) from the client for the work inter alia indicating final executed amount and date of completion or any other document, authenticated by the client, containing relevant information to conclusively establish that the bidder has completed the requisite works satisfactorily.



2.2 FINANCIAL POSITION: -

• Minimum Average Annual Turnover* (MAAT) for the best three financial years, out of last five financial years of the bidder should not be less than **Rs.744.20 Lakhs**.

NOTE: Relaxation for MSEs/ Startups

START-UPs^^ meeting the specified requirements at para 2.2 above, shall also be considered qualified if they meet 80% (Eighty percent) of the requirements specified at para 2.2 above i.e Rs.595.36 Lakhs

^^START-Ups as defined by DPIIT, applicable as on the originally scheduled date of bid opening.

- · The requirement of MAAT for MSE bidders is waived off.
- LA (Liquid Asset) and Net Worth of bidders are not required.

*Note: "Annual gross revenue from operation/gross operating income as incorporated in the profit & loss account excluding other income".

- Net worth of the bidders for last 3 financial years should be positive
- Bidder shall have liquid assets (L.A.) or/ and evidence of access to or availability of credit facilities of not less than Rs. ——Lakhs (excl GST)

In case bidder is a holding company, the **financial position criteria** referred to in clause 2.2 above shall be of that holding company only (i.e. excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the **financial position criteria** referred to in clause 2.0 above shall be of that subsidiary company only (i.e. excluding its holding company).

2.4 The bidder shall also furnish following documents/details with bid-

- (a) The complete annual reports together with Audited statement of accounts of the company for last five years of its own (separate) immediately preceding the date of submission of bid.

- (d) A copy of Completion Certificate from the Client for completed works or Performance Report from the Client or any other document like Acceptance of Final Bill by client.
- (e) List of work regarding past experience indicating the execution of similar work successfully, schedule time of completion and actual time of completion, the present status of projects in hand along with presently envisaged completion dates, qualification and experience of key personnel proposed for carrying out the subject work. List of available T&P and Manpower available with the bidder is also to be enclosed.

- 3. INTEGRITY PACT: Integrity Pact is required for package with estimated cost of Rs.1(one) erore or above only. The bidder shall have to submit an Integrity Pact (in 02 copies) on non-judicial stamp paper of Rs.100/- as per pro-forma enclosed with Tender Form. One copy shall be retained by BIHARGRID and the other copy shall be returned to the bidder duly signed by BIHARGRID representative.
- 3.1 INSTRUCTIONS FOR EXECUTION OF THIS INTEGRITY PACT (These are instructions for execution and does not form part of the Integrity Pact)-
- (a) Integrity Pact' is to be executed in two (02) originals.
- (b)) Bidder shall submit the Integrity Pact on a non-judicial stamp paper of Rs.100/- duly signed by the person(s) signing the bid.
- (c) The non-judicial stamp papers are to be purchased in the name of the Bidder or BIHARGRID and the date of purchase should not be earlier than six months of date of execution. The same is to be attached with this bound volume mentioning the following on the stamp paper:

- (d) Bidders are required to clearly indicate the name of the package and its NIT Reference Number on the stamp paper/covering letter and first page of the Integrity Pact.
- (c) All the pages of the integrity pact are to be signed by the Bidder. If the Bidder is a partnership or a consortium, the Integrity Pact shall be signed by all the partners or consortium members.
- (f) Bidders are required to clearly indicate the name and designation of the signatory(ies) as well as the name and address of the witnesses.
- (g) The Bidder shall not change the contents of the Integrity Pact.
- (h) Bidder may note that Bidder's failure to submit the Integrity Pact duly signed along with the Bid shall lead to outright rejection of the Bid.
- 4. Notwithstanding anything stated above, BIHARGRID reserves the right to assess the bidder's capability and capacity to perform the contract, should the circumstances warrant such assessment necessary in its overall interest. Bidder may have to produce originals of documents submitted to qualify against the package, which shall be returned after verification & shall not be retained by BIHARGRID. Authenticity of documents submitted by bidders may also be verified by BIHARGRID as deemed fit through its own sources.

- 8. However, issue of bid documents will not automatically mean that such bidders are considered qualified.
- **8.1** The bidder(s) shall be required to submit credential paper like company profile, Copy of PAN Card, Copy of Partnership Deed/ Affidavit for Proprietorship/ Company MoA & AoA or Certificate of Incorporation, as applicable, Copy of GST Registration Certificate, LOA copy, completion certificate, payment certificate, last five years audited balance sheet and profit and loss account certificate, P.F Registration, Labour license etc. for meeting the qualifying requirement as mentioned at para 2.1, 2.2, 2.3 & 2.4 above respectively.
- 9. The bidders have option for sending bid by courier/ post or submitting the bid in person. However, the bid should reach at the address below/ address given in 'ITB',



not later than the time & date mentioned at para 1.0 above. The owner may, at its discretion, extend this deadline for submission of bids at any time prior to opening of bids by the Employer.

LATE BID

Any bid received by the owner after the time & date fixed or extended for submission of bids prescribed by the owner, will be rejected and/ or returned unopened to the bidder.

- 10. It is imperative for each bidder/ tenderer to satisfy himself completely of all local conditions, nature of ground and its subsoil conditions at the required locations. Bidders, if they consider it necessary, have the permission of the owner to carry out survey and soil investigations for aforesaid purpose. In addition, the bidder are expected to assess any problem relating to the means of access to the site, the accommodation they may require and its availability, besides any other aspects including financial implication affecting on the execution of the work(s) covered under these documents and specifications. A bidder shall be deemed to have full knowledge of the site (whether he inspects or not).
- 11. BIHARGRID reserves the right to accept or reject any or all the bids without assigning any reason whatsoever. BIHARGRID also reserves the right to pre-pone /postpone the above dates, split and distribute the work among more than one bidder without assigning any reason whatsoever.
